
Caritas = Love

One of the leading actors in provisioning quality employability services to its beneficiaries and is open to collaboration and synergies.

Since the design phase of its employability hub services, Caritas Hellas aimed at a rounded approach which takes into consideration the **analysis of the labour market and legal framework and offers a holistic model of support and accompaniment for the job seekers**. To live up to this goal, Caritas Hellas,

- conducted research with methodologies such as the **value chain market analysis in Athens**,
- developed **digital tools** such as the **Online Platform** and **App** linking Refugees to Employment and Training Opportunities,
- hired **professional job counsellors** and **social entrepreneurship experts**
- supports **social economy initiatives** and
- runs Pilot Programs in its shelters (ESTIA) and Social Services Centres.
- Partner in the “NADINE” project (Horizon 2020)






host communities in Athens


Socio-economic integration of Refugees in Greece
