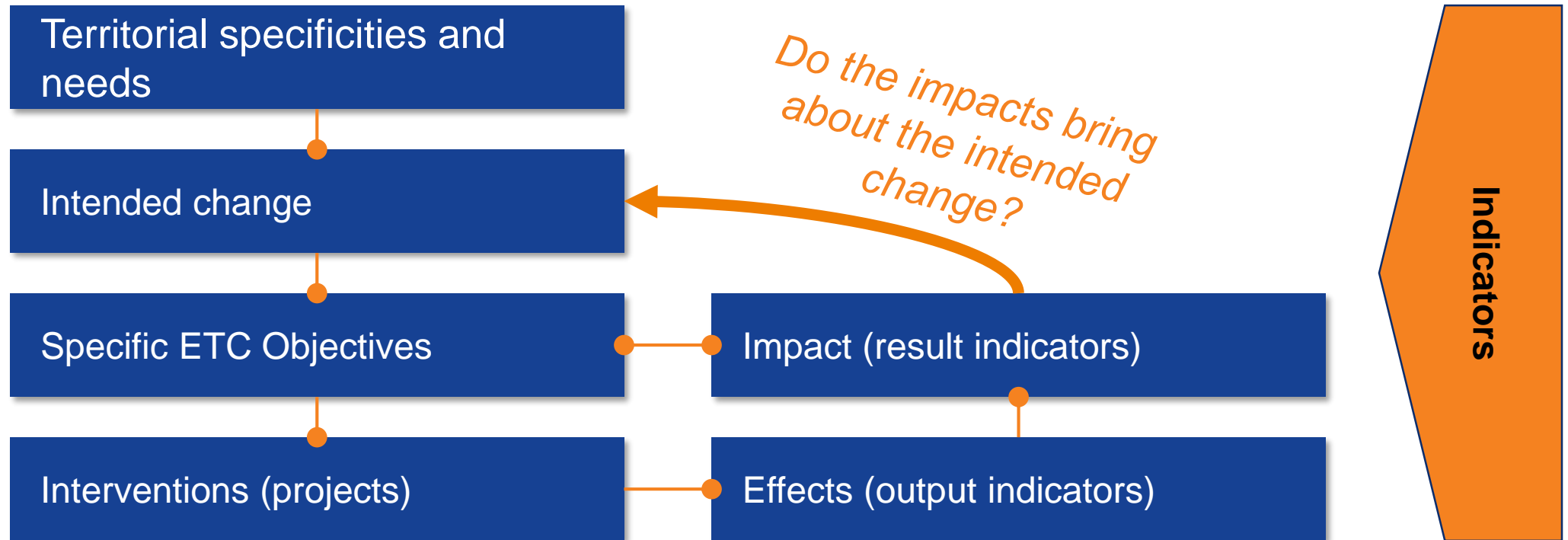

The intervention logic of ETC Programmes



Specificities of ETC Programs

- ETC programs act in the same frame as all programs
- policy justification requires a clear link funded projects - specific objectives
- Resources are limited compared to other European programs
- Territorial co-operation is not easy to assess

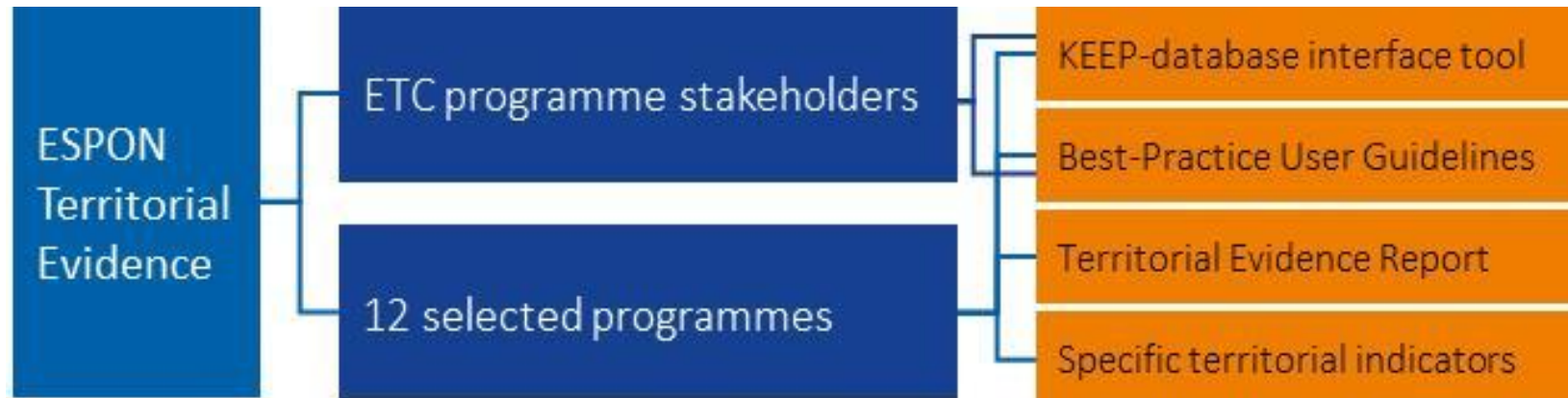
Special challenges of ETC programs

- ➔ actual effects on the development of regions caused by ETC programs are quite limited due to limited resources
- ➔ availability of indicators picturing cooperation effects is limited

Territorial Evidence Support for ETC-Programmes: Goals+results

Goal: The development of a set of synthetic key territorial indicators ...

- that best reflect and capture the results of socio-economic interventions
- by corresponding to the characteristics of ETC programmes
- and that help ETC stakeholders in monitoring and evaluating of ETC programmes

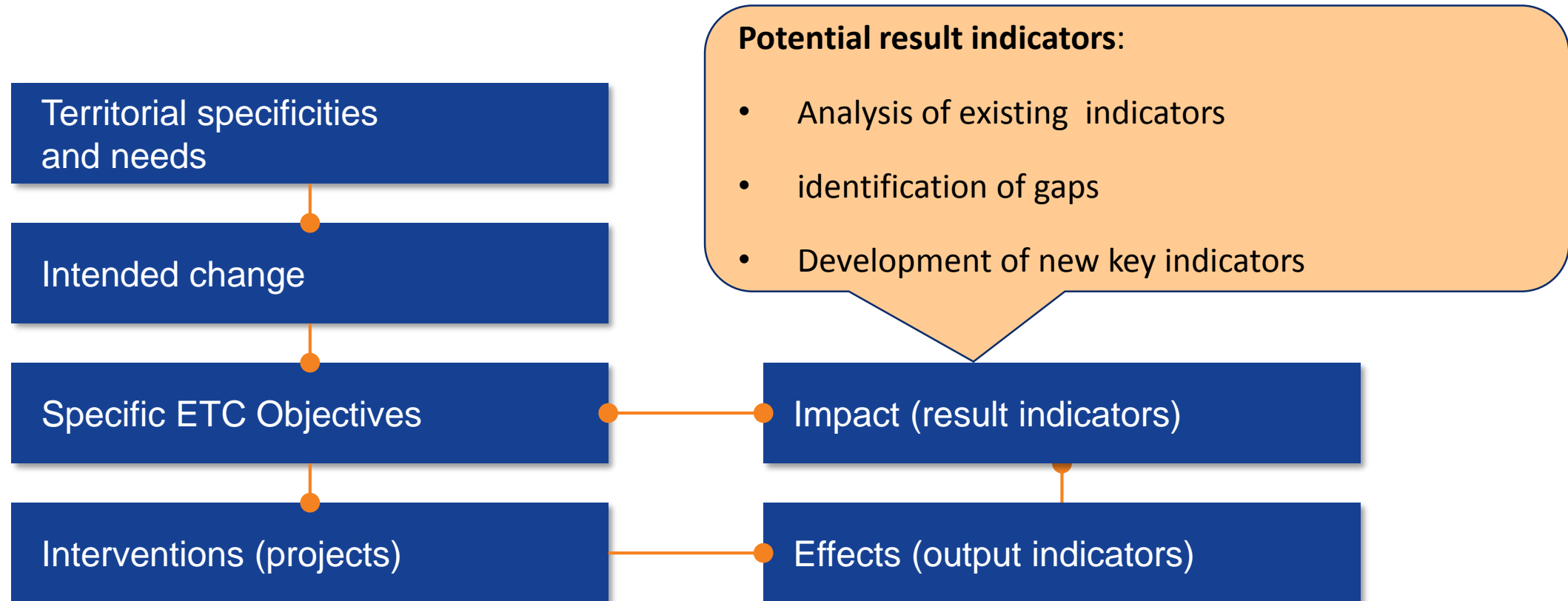


Analysis of ETC OPs – Typical “ETC specific objectives”

- Analysis of 12 OPs with more than 70 specific objectives
- deduction of 16 “ETC specific objectives”
- development of “typical” ETC intervention logics

Thematic objective	Identified “ETC specific objectives” based on specific objectives of 12 OPs
TO 5. Promoting climate change adaptation, risk prevention and management	vii. Territorial coordination for improved disaster prevention and support of resilience against natural and manmade disasters across borders
