Message from the ESPON Coordination Unit

First ESPON 2013 Scientific Report:

"Scientific Dialogue on Cities, Rural Areas and Rising Energy Prices" and substantial interest for current ESPON Call



One of ESPON's objectives since the start in 2002 has been to support the establishment of a European wide research community in the field of European territorial science. The aim being to increase the academic interest and competences in research on European territorial structures, trends, perspectives and impacts of EU sector policy.

ESPON has promoted this scientific component through conferences and workshops, cooperation with European organisations in the fields of regional science, geography and spatial planning, as well as with a dedicated series of reports mainly targeting the scientific community.

During the former ESPON 2006 Programme, two reports on scientific progress were published. Now the recently published, first ESPON 2013 Scientific Report continues and further develops this tradition. Scientific dialogue on the research findings is crucial through academic papers and presentations at academic conferences. This new as well as the planned additional ESPON Scientific Reports should substantially contribute to the scientific dialogue at European level among researchers and experts aiming at contributing to a scientific base for future policy development related to territorial development and cohesion.

The interest for taking part in ESPON projects is high. At the recent ESPON Info day in Brussels related to the current open calls, several hundred participants registered and were informed. This is a promising indication for ESPON which will hopefully result in many applications and teams of expertise competing in this round of calls.

We hope you will enjoy reading the First ESPON 2013 Scientific Report Please and its collection of 20 maps. And please alert potential ESPON applicants and other interested parties on the actual Call for Proposals and Expressions of Interest that will all close with the deadline of 21 March 2011. This would support the building of the pan-European comparative evidence on territorial dynamics that ESPON stands for.

1. ESPON Calls

Open Call for Proposals and Expressions of Interest (24 January – 21 March 2011)

The 8th ESPON Call for Proposals and Expressions of Interest is open.

The available budget amounts to up to 5.493.000, 00 Euro covering the following:

1) Applied Research Projects (Priority 1)

- European Regions: Potential Contribution to the EU 2020 Strategy
- Territorial Scenarios and Visions for Europe
- Territorial Potentials for a Greener Economy
- Territorial Governance Best Practices for New Perspectives
- 2) Expression of Interests by stakeholders for Targeted Analyses (Priority 2)
- 3) Scientific Platform (Priority 3): EU Territorial Monitoring and Reporting System

The deadline for submitting proposals is 21 March 2011.

Potential beneficiaries

Public and private body can apply for the Call for Proposals on Applied Research Projects and the Call for Proposals within the ESPON Scientific Platform.

Only public authorities are considered as stakeholders in the Call for Expressions of Interest.

ESPON Info Day on New Calls and Partner Café on 10 February 2011

The new Call was presented during the Info Day which took place in Brussels on 10 February 2011. More



than 230 participants from 170 different Institutions and 24 countries attended the event, among them policy makers, scientists, experts, representatives of universities, research institutes and companies around Europe.

The purpose of the event was to inform and assist potential beneficiaries in preparing proposals for the Call.

The event focused on the content specifications and the procedures for applying. The European Commission and the Hungarian EU Presidency presented the policy demand behind the need for further ESPON results.

The ESPON Coordination Unit provided participants with a brief on the achievements and prospects on the Programme.

Participants learnt about opportunities for taking part in ESPON project activities and themes and objectives of the Call.

The session on "How to Apply" focused on the legal framework, the eligibility criteria, the modalities for applying.

The programme ended with a Partner Café creating a forum for dialogue between potential project partners. The Partner Café gave participants the chance to network, to find partners for their projects and get feedback.

Call for Expression of Interest for the Knowledge Support System (23 November 2010 – 21 January 2011) attracted 100 expressions of interest from 21 EU countries

ESPON closed its 7th Call on 21 January with 100 expressions of interest. Of the applicants, 20% came from Romania, 15% Italy, 14% from Spain, 7% from Czech Republic, 6% France, 4% from Hungary, Poland, Slovenia. The applicants are from 21 European countries.

Evaluation of the applications will run during February - March and the results will be tabled for the ESPON Monitoring Committee late March 2011.

2. ESPON Results and Reports

First ESPON 2013 Scientific Report - Scientific Dialogue on Cities, Rural Areas and Rising Energy Prices



ESPON has recently published its First Scientific Report which aims at substantially contributing to the scientific dialogue among researchers and experts around Europe in order to build a scientific base for future policy development.

The Report "Scientific Dialogue on Cities, Rural Areas and Rising Energy Prices" presents the methodologies used within ESPON projects to explore comparative advantages and develop concepts, indicators, typologies and European maps on territorial development, competitiveness and cohesion through a dialogue among researchers, practitioners and policy makers.

This Report includes three scientific papers arising from ESPON research carried out between 2008 and 2010 under the auspices of the ReRisk, FOCI and EDORA applied research projects. Together, the three scientific papers collectively reinforce

the importance of metropolitan agglomeration, the significance of connectivity and the shared vulnerability to climate change.

They reinforce the territorial diversity of the EU and the variety of potentials for economic growth that exist in different regions of Europe. Each of the three paper presents new insights into processes of change that require further examination, but each also rigorously explores how data might be analysed.

Map of the Month "Wind Power and Photovoltaic Potential in the EU Regions"

Europe is entering a new energy landscape with rising energy prices, creating opportunities for the development of renewable energy resources, creating employment and new sources of income. This far-reaching transition process of the energy sector creates a need for informed policy and investment actions,

as policy decisions taken today will be an important element in future competitiveness of regions, cities and different parts of the European territory, in which the prospects differ significantly.

This month ESPON produced 2 maps which demonstrate that the potential for exploiting renewable energy varies for different territories and regions in Europe.



The map on the <u>wind power</u> identifies those regions in Europe, which have the highest potential for producing electricity from on-shore wind power.

These regions are located in Sweden, Finland, Ireland, Estonia, Latvia and Lithuania as well as the north of Norway and Scotland.

Most of these areas are however very distant from major urban markets where the demand for electricity is concentrated.



The map of <u>solar energy potential</u> shows the regional potential for electricity production from solar panels.

The difference is that the regions with greatest potential are now in the south and east of Europe. The core area of Europe is scoring low, while the main potential lies on the periphery.

The maps have been developed by the ESPON Applied Research Project Re-Risk (Regions at Risk of Energy Poverty).

DEMIFER Final Report

ESPON published the final report of the Applied Research DEMIFER - Demographic and Migratory Flows affecting European Regions and Cities.

Two main developments form the point of departure for the project:

- The ageing of the population in Europe in the next decades. A major consequence of the ageing of the population is that the working age population will decline which may have a downward effect on economic growth and competitiveness in many European regions.
- 2. The challenges European regions will have to face from environmental changes, particularly climate change and limitations in the availability of energy.

Even though ageing and environmental change are global developments, the consequences may be different for different regions and may affect migration flows across regions in different ways. The key objective of DEMIFER therefore was to assess the effects of demographic trends and migration flows on European regions and cities and to examine the implications for economic and social cohesion, taking into account the possible effects of climate change.

DEMIFER was carried out in the period 2008-2010 by a team of researchers from the Netherlands Interdisciplinary Demographic Institute (Lead Partner), the University of Vienna/Faculty for Geosciences, Geography and Astronomy, the International Organization for Migration/Central European Forum for Migration and Population Research, the University of Leeds/School of Geography, the Netherlands Environmental Assessment Agency, Nordregio/the Nordic Centre for Spatial Development and the National Research Council/Institute for Research on Population and Social Policies.

ESPON ReRisk - Regions at Risk of Energy Poverty, the Final Report is now online

Energy seems to keep the EU agenda busy this year. Hungary is planning to concentrate on the EU energy policy while it takes on the EU's rotating presidency and energy was the core theme at the new presidency's first EU summit on 4 February 2011. Hence the ReRisk Report seemed to be just in time to feed the current political discussions.

Political pressure to fight energy poverty is mounting, but policy initiatives in this field are hampered by the lack of basic data on the energy consumption in European regions. The ReRisk Report, produced by INNOBASQUE as Lead Partner and Nordregio together with National Technical University of Athens as Project Partners, tries to fill this gap by presenting findings on the implications of energy poverty for economic competitiveness and social cohesion in the regions of the European Union.

The Project clearly presents a unique approach by having an accent on the topic of energy use more than on energy production. It is the economic and transport structure, as well as the social situation and the climate conditions, which makes certain regions in Europe more vulnerable to energy poverty than others. The Report also shows that increasing prices for fossil fuels open up opportunities for the development of renewable energy resources and the creation of new sources of income and employment.

ESPON PURR is making progress: its Inception Report is online.

The aim of PURR - Potential of Rural Regions – is to create and test new ways to explore the territorial potentials of some rural areas and small and medium-sized towns in peripheral parts of Europe around the North Sea, the Irish Sea and the Baltic Sea. These places face problems such as ageing, migration, poor accessibility, restructuring of traditional industries and are further threatened by rising energy costs. However, they also possess some territorial assets related to their natural and cultural heritage and in the sense of identity that many have.

The Inception Report presents a more detailed overview of the analytical approach to be applied by the project. The TPG intends to make optimal use of the outputs of the EDORA project and this includes the EDORA conceptual framework. The challenge for PURR will be to apply this conceptual framework to specific contexts and to make any adaptations that are necessary.

PURR is produced by the Norwegian Institute for Urban and Regional Research as Lead Partner and London South Bank University and Vidzeme University of Applied Sciences as Project Partners. More reading at the ESPON Website.

FOCI - Future Orientation for Cities, the Draft Final Report is online

The FOCI project analyses the current state, trends and development perspectives for the largest cities and urban agglomerations within the European territory. Its Draft Final Report sets out the emerging project findings.

The report provides a general overview of the state and perspectives of city development based on a review of scientific literature. In addition the report presents some new empirical findings that add up to the current discussion on city development.

The empirical findings include territorial evidence on economic and social development of cities in Europe, on spatial appearances of European cities (extension, form, city-hinterland relations) and on co-operation. The report finally includes elaborated scenarios helping cities to assess and address their upcoming challenges.

EU-LUPA - European Land Use Patterns produced its Inception Report

The objective of the project is to develop a consistent methodology for analysing comparable information about European regions and cities, based on data from different sources and at different levels.

Moreover, the project aims to supply regionalised information integrating the physical dimension (land cover) with socio-economic (land use) and environmental dimensions, in order to understand land use dynamics, land use changes and current land use patterns in the European territory, identifying main challenges in different types of territories, regions and cities and defining the policy recommendations to cope with the challenges.

The Inception report provides a description of the conceptual framework and project methodological approach, first results in relation with data availability, identification of potential case studies, project results and main targeted groups.

EU-LUPA, produced by Labein-Tecnalia - Technology Centre as Lead Partner and Universitat Autònoma de Barcelona, Alterra, Nordregio, S. Leszczycki Institute of Geography as Project Partners, shall deliver its Interim Report by 3 June 2011. More reading.

ESPON Financial Managers Seminar – 31 March and 1st April in Geneva



4. Use of ESPON – an example at national level

ESPON projects in the Finnish context



The Karelian Institute at the University of Eastern Finland, in cooperation with the Centre for Urban and Regional Studies (YTK) at Aalto University, recently released the publication "ESPONin ytimessä ja ympärillä" (In and around the core of ESPON) which analyses ESPON results in relation to research touching on similar topics in Finland.

The publication (in Finnish language) includes 10 articles on the expectations that experts have from the ESPON 2013 Programme. The topics of the articles include, among others, the role of territorial diversity in development policies, the territorial effects of climate change, the methodology of territorial impact assessment and the relationship of research and policy-making.

This publication, sixth in the series, is part of the ESPON activities in Finland hosted by the Finnish ECP and financed by the Ministry of Employment and the Economy and the Ministry of the Environment.

More than 180 people attended the events: representatives of the research institutions, universities, public authorities, practitioners and young academics.

Present at the Bucharest Infoday on the 3rd of February 2011, Mr. Eugen Curteanu, State Secretary in the Ministry of Regional Development, emphasised the important role of the public authorities played in the use of ESPON results and invited public authorities to look at the correlation between the results and local realities thus helping the ministry in the improvement of the national strategies.

With the help of the Municipality of Timişoara, the Infoday on the 15th of February was transmitted online on the website www.primariatm.ro giving potential beneficiaries that could not participate at the event to watch the meeting on the Internet.

The Iaşi Infoday on the 17th of February was opened by the Professor dr. Ovidiu Gabriel Iancu, Dean of the Faculty of Geography within the University Al. I. Cuza from Iaşi, who encouraged the participation of the Romanian institutions at the ESPON call and emphasised on the important role played by the Romanian ECP in support of the participation of the Romanian institutions to ESPON project proposals.

The agenda of the events focused on: information on the new call, procedures on the formulation and submitting of the project proposals, sources for the identification of the partners, first level control and reimbursement of the expenditures, Romanian institutions participating in ESPON projects: <u>ESPON Climate</u>, <u>ESPON TeDI</u>, <u>INTERSTRAT</u>, <u>ESPON Database</u>.
