Topics and Aims

The MONTESPON Seminar aims to foster better understanding of the specific situation, challenges and opportunities in the European mountainous regions and to facilitate mutual learning between different actors dealing with mountain development. In that respect, it will also be an opportunity to bridge the gap between the ESPON programme and Interreg III / Interact projects dealing with mountain topics, as key actors from the 3 programmes will be present.

Mountain-related findings of ESPON studies will be presented, discussed and compared with results from Interreg III projects. Four thematic groups of topics will provide a starting point:

- Demography and public services (demographic change, migration, new sociodemographic structures, situation of public services in mountain regions, new strategies to optimize the provision of public services)
- Economy and accessibility (economic structure and trends, diffusion of new branches, unemployment / loss of jobs, development of accessibility, quality of private and public transport, link between accessibility and economic development)
- Landscape and natural risks (development of mountain landscape due to natural and socio-economic impacts, climatic change and natural risks)
- Regional governance and new institutions (institutional setting of mountain policy, autonomy vs. external encouragement, concepts for territorial cohesion)

Within all these topics, new challenges, opportunities and risks for spatial policy on international, national and regional level will be highlighted.

Target groups

The target groups of the seminar are the ESPON community (Monitoring Committee, ECPs, TPGs, other partners) as well as representatives from various Interreg and Interact projects, from administrations, NGOs, planners / consulters and scientists active in the wide field of mountain development policy.
