### **Message from the ESPON Coordination Unit:**

#### **The Global Economic Crisis, European Regions and Cities**

Back from until now the largest ESPON Seminar, the understanding of the **regional and local effects of the global economic crisis** is a hot topic for policy makers, practitioners and scientists.

When addressing the global economic recession it is crucial to underline that the crisis is in progress. Despite the first encouraging signs of recovery, it is by far not sure that important features of the real economy, unemployment and closure of companies have passed the bottom. Attempts to measure the territorial footprint of the crisis at this stage will therefore only give a snapshot, and not indicate perspectives for the medium-long term. In addition, an evidence-based understanding of impacts based on facts on regions and cities is not yet possible as data broken down to regions and cities are not yet available.

Observations of structural developments, however, allow already formulating informed guesses on some territorial effects of the current crisis. The speakers and the discussions at the ESPON Seminar on 3-4 June 2009 in Prague took a first intelligent step to shape the understanding of the possible effects. Some of the key messages were:

- Some countries are affected more than others depending of the solidity of the national economy and the consequences on domestic demand.
- The crisis accelerates structural change of regional economies which will be due in the long term, generating threats as well as opportunities for regions pending on their assets and potentials.
- Regions are hit in an asymmetrical pattern just like micro-regions and towns depending on the vulnerability in their economic base.
- The economic specialisation of regions and the structure, size and solidity of local companies are important for the impacts experienced.
- Some regions do better than before apparently un-affected or benefiting of the current economic situation.
- Bigger cities could suffer more than smaller ones as their integration in the world market is more profound.
- Large cities seem however better equipped to absorb negative impacts of the crisis as their capability to substitute labour market effects is higher.
- In Central and Eastern Europe, capital cities seem less affected by the economic downturn than in other parts of Europe.
- Long term benefits should be the focus of recovery measures taken by regions and cities addressing the opportunities inherent in the diversity of assets.

- Territorial diagnostics should be enhanced as a tool in finding the best measures in combating the crisis.

Summing up the first discussion, it seems that country and sector specific impacts hit regions and cities in random territorial patterns. This is due to regional/urban vulnerability. Contraction/lay-off seems often to depend on a combination of national economic vulnerability, the degree of export orientation in the regional/local economy and the presence of economic sectors with high vulnerability, such as finance and banking, housing and the automotive industry. The solidity of individual businesses is also an important factor that seems to explain some negative impacts on local labour markets. Whether larger or smaller cities in general conquer the current challenges best is disputed by experts and remains to be seen based on data and facts.

## **ESPON Open Seminar “Territorial Development Opportunities in the Global Economic Recession”**

The Seminar took place in Prague on 3 – 4 June 2009 and was organised in cooperation with the **Czech Presidency of the European Union** in the presence of Minister Rostislav Vondruška, Ministry for Regional Development of Czech Republic, Dirk Ahner, General Director of the **European Commission DG Regio** and representatives of the Organisation for Economic Co-operation and Development (**OECD**) and the European Investment Bank (**EIB**). Around 250 participants attended the seminar, among them policy makers and scientists from Europe and neighbouring countries.

The Seminar brought about many interesting interventions and observations on territorial dimensions of the global economic crisis and what challenges and opportunities exist for regions and cities. ## **New Calls in September 2009 on ESPON Applied Research, Targeted Analyses, Scientific Progress and Transnational Networking Activities**

The next calls for Proposals and Expression of Interest are envisaged by mid September 2009. The deadline for submitting proposals and express interest is foreseen by mid November 2009.

(1) Calls for Proposals will be opened for the following 11 themes of Applied Research (under Priority 1 of the ESPON Programme) that have been decided by the Monitoring Committee:

- Attractiveness of European regions and cities for residents and visitors
- European patterns of land use
- Territorial cooperation in transnational areas and across internal/external borders
- Transport accessibility at regional/local scale and patterns in Europe
- Secondary growth poles in territorial development
- European perspective on specific types of territories

- Territorial dimension of the innovation and knowledge economy
- Continental territorial structures and flows (globalisation)
- Indicators and perspectives for services of general interest in territorial cohesion and development
- European seas in territorial development
- Territorial and regional sensitivity of EU Directives

(2) Targeted analyses, the new type of ESPON projects (under Priority 2), will be further implemented through the following calls:

- Call for Proposals: Potential of Rural Regions/PURR (TCAP1), Transnational Support Method for European Cooperation/TransSMec
- Call for Expression of Interest: (Up to) 10 new project ideas

(3) In support of the scientific platform under ESPON activities (under Priority 3 of the ESPON Programme), one of three major projects will be open:

- Call for Proposal on Territorial Indicators/Indices

(4) Capitalisation in the transnational context will start with the first round of projects carried through by teams of ESPON Contact Points by opening the following call:

- Call for Proposals for up to 7 Transnational Activities of the ESPON Contact Point Network

Participation of private partners will be possible in the calls for Proposals on Applied Research projects and Targeted Analysis as well as the project on Territorial Indicators/Indices.

Only public authorities are accepted in calls for expression of interest for Targeted analyses, and only institutions confirmed as ESPON Contact Points can submit proposals on Transnational Networking Activities.

## **New ESPON Inception Reports**

**(1) The Inception Report of TeDi - Territorial Diversity in Europe is available at the ESPON Website**

The overall objective of this project is to provide a better understanding of development processes in territories outside the Pentagon that are defined as insular, mountainous, sparsely populated or peripheral. The analysis aims particularly at highlighting how these territories may contribute to the achievement of overarching European objectives expressed in the Lisbon and Gothenburg Strategies. By focusing on a representative sample of such regions, the project will be drawing more general conclusions for territories subject to similar territorial specificities across Europe. **(2) The Inception Report of METROBORDER – Cross-Border Polycentric Metropolitan Regions has been published at the ESPON Website.**

This project addresses cross-border metropolitan regions in Europe in relation to the policy aim of polycentric development. It aims at identifying criteria, potentials and governance

practices based on available ESPON evidence for polycentric cross-border metropolitan regions in Europe and proposing options for development strategies towards a multilevel approach for two case study regions (Upper Rhine Region and the Greater Region).
