The aims of the third ESPON seminar are to present, assess and discuss the preliminary results accomplished by the Transnational Project Groups as well as their first ideas for policy recommendations.

The Interim Reports delivered end August 2003 are a major milestone for the ESPON Programme as the policy discussions on territorial cohesion develops. For the ESPON Programme it is important that the new knowledge provided on trends and policy impact on the enlarged European territory are solid in a scientific sense and operational in a political context.

The preliminary results and policy recommendations included in the Interim Reports is the main focus of the seminar. Each Lead Partner is invited to present the work of the TPG concentrating on the main findings, key choices made, use of the common platform and challenges for the next phase of the project. Following each presentation the seminar programme makes room for discussion.

A special slot will focus on the first policy recommendations coming out of the Interim Reports, which will give the participants of the seminar, and in particular the ESPON Monitoring Committee, an opportunity for a direct dialogue with the TPG.

At the end of the first day parallel workshops are envisaged to focus on progress made on ESPON mapping tools, experiences in the process from goals and concepts to policy recommendations and on indicators, typologies and cross-thematic analysis.
